Bob Graf Memorial Scholarship Fund	This \$1000 scholarship supports a Greater Itasca County area student(s), both traditional and non-traditional, who is pursuing a technical, trade, or nursing degree and has a GPA of 2.0-3.5. Past recipients may re-apply.
Bonner Hockey Scholar Award	This \$500 scholarship is awarded to the GRHS graduating senior male and female varsity hockey player (must have played during their senior year) with the highest cumulative GPA on their respective hockey team.
Brad Smith Memorial Scholarship	This \$900 scholarship supports a graduating Deer River High School student who demonstrates exceptional commitment to self and community. Past recipients may re-apply.

This scholarship is available to both traditional and non-traditional students. Past recipients may re-apply.

Dan Retka Memorial Scholarship	This \$500 scholarship supports GRHS graduating seniors with a GPA of 3.0 or higher who plan to study engineering, construction management or environmental science. Past recipients may re-apply.
Deer River Schools Endowment	This endowment supports the programs and projects of Deer River School.
District 318 Endowment	This endowment supports the programs and projects of District 318 (Grand Rapids and Bigfork schools).
Dr. and Mrs. Robert Kelly Scholarship	This \$2500 scholarship is intended for an individual who has earned at least a high school diploma and, due to life or career circumstances, has experienced an "interruption" in their career path. The ideal candidate is someone who has decided to pursue a career track in the healthcare field. Past recipients may re-apply.
Dr. Jules and Ilo Meyer Medical Scholarship	This \$5000 scholarship supports traditional and nontraditional students entering medical school, dental school, veterinarian school or a registered nursing program.
Eagle Scholarship	This \$500 scholarship supports traditional or nontraditional students in the Greater Itasca Area who plan to attend a Christian-centered college, university, Bible college, or seminary. Past recipients may re-apply.
Ed and Eleanore Gregerson Scholarship	This \$10,000 recurring scholarship (\$2500 for four years) supports GRHS graduating seniors who are active members of the Zion Lutheran Church of Grand Rapids and who plan on pursuing a 4-year degree.
Edgar R and Bess R Mullins Award	This \$1500 scholarship is awarded to one female and one male graduating senior from Greenway High School who demonstrates athletic involvement, leadership, and commitment to GHS and their community.
Erling and Fran Willadson Scholarship	This \$1000 scholarship supports graduating GRHS seniors who are pursuing a vocational or technical school program. Past recipients may re-apply.
Essentia Health - Future in Healthcare Scholarship	This \$5,000 scholarship supports a Greater Itasca Area student, both traditional and nontraditional, who is pursuing a major in healthcare that includes dental and mental health services and maintains a GPA of 3.25 or higher. Past recipients may re-apply.
Forrest Willey Memorial Scholarship Fund	This \$1000 scholarship supports GRHS and Northern Lights Community School graduating seniors who have a GPA of 2.5 or higher.
Foster Hope Scholarship Fund	This \$1000 scholarship supports traditional and nontraditional students in the Greater Itasca Area who are currently in the foster care system, have previously been in the foster care system, or who have been adopted through the foster care system and who are pursuing further education and have a GPA of 2.0 or higher. Past recipients may re-apply.
Frances Bartos King-James E. King Scholarship	This \$2000 scholarship supports female Greater Itasca Area graduating high seniors who are pursuing further education. May be based on financial need. Past recipients may re-apply.
Freestone Community Club Scholarship	This \$500 scholarship supports graduating seniors from GRHS who live in the Arbo, Bass Lake, Deer Lake or Wabana Townships.
Gary Ehalt "His Love For Animals" Veterinary Scholarship	This \$750 scholarship supports Greater Itasca Area students, both traditional and non-traditional, interested in becoming a veterinarian. Past recipients may re-apply.
G.J. Holt Family Scholarship	This \$6000 recurring scholarship (\$1500 for 4 yrs) supports Bigfork High School graduating seniors who are pursuing further education. It is renewable up to three additional years based on student progress and performance in their schooling.
Grace Christian School Endowment	This endowment supports the programs and projects of Grace Christian School.
Grand Itasca Clinic and Hospital Volunteer Services Scholarship	This \$3000 scholarship supports Greater Itasca Area students who have at least two years of college and are pursuing a career in healthcare. Past recipients may re-apply.
Grand Rapids AAUW Anniversary Fund	The Grand Rapids Branch of AAUW provides a \$1500 scholarship each year for a woman who has completed a minimum of an associate degree or equivalent, who is 25 years or older, with a 3.25 GPA, and working toward a certification program, a bachelor's degree, or a master's degree. In 2006, the Grand Rapids AAUW Branch, to commemorate their 60th anniversary, began a drive to provide the Anniversary Scholarship. Past recipients may re-apply.

Grand Rapids/Greenway Swim Association Scholarship	This \$750 scholarship supports two graduating seniors from GRHS or GHS pursuing further education who participated in at least 3 years of competitive swimming, preferably at the varsity level, who have a GPA of 2.5 or higher, and who demonstrate team leadership, good sportsmanship, promote team spirit, unselfishness and have a willingness to help others.
GRHS Class of '85 Legacy Scholarship	This \$1000 scholarship supports GRHS students, both traditional and nontraditional, who are pursuing further education. Preference may be given to students based on financial need.
GRHS Climate Fund	The fund shall be used for charitable support of positive relationships between school staff, faculty and students.
GRSB Financial Focus Scholarship	This \$1000 scholarship is awarded to graduating seniors from the Greater Itasca Area. The student receiving the scholarship must have a minimum GPA of 2.5 and be enrolled in a Community, Technical, College or University. This scholarship is given to students going into a financial focused related field.
